- Their spouse held a valid passport in their name for that country at the time of their marriage.

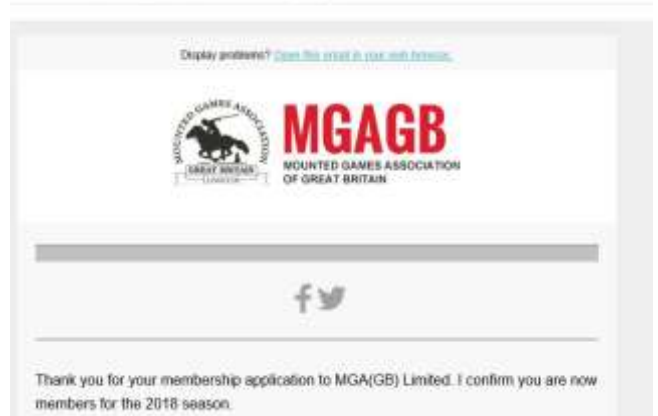
For England North and England South the rules are different and the only criteria allowed is that you must have been born or have lived in the region for 3 years.
